Here it is important to know and make a distinction between language disorder and speech disorder. These two types of disorder need to be treated differently and distinctly. In short, one is the disability of understanding and the other is the disability of production. Apraxia, dysarthria and stuttering of voices are the examples of speech disorder and aphasia is an example of language disorder. There are some medical conditions which may cause language and speech disorder. The medical conditions are amyotrophic lateral sclerosis, dementia, Huntington's disease, laryngeal cancer, oral cancer, right hemisphere brain injury. Out of these medical reasons brain injury is the most critical medical condition which requires special medical attention and it is the reason of speech and language disorder. Along with physical injury to brain, the injury caused by trauma is also the medical condition which may cause serious language and speech disorders.

It is sufficiently known that there are certain medical conditions which may cause language and speech disorder. But it is not the universal truth. The world order is created for normal people and the educational system, social system are formed in such a way that only normal people (normal here in the sense that those who are medically declared fit) are able to perform. Those who don't fit in these conditions are declared as unfit or disable people. The disability is definitely a medical issue but the problem of disability is made bigger when it is treated only as medical issue.

Children with language learning disabilities may work as good as normal people and there is no reason they should be treated differently for their disabilities. Children with hearing and orthopedic impairment can be good enough in performance as compared to normal children.
